General Service News from your GSRs

Greetings from your District 15 GSRs! We have decided to issue a newsletter to all 45 groups in our District, hopefully answering questions about General services, and soliciting feedback from you as to what other questions or services we could provide to you. Please give us your feedback via your GSR.

Here are a few of the most commonly asked questions, and some brief answers:

Question: Who runs AA worldwide?

Answer: The AA groups do. Each issue that affects AA as a whole gets voted on by AA groups throughout the U.S. and Canada. Each group's vote is carried by its GSR (General Service Representative) to their Area Delegate. The Area Delegates from all 93 of the Areas in the U.S. and Canada then meet once a year to discuss the issues and the opinions of the AA groups in their respective Areas. A group conscience is taken, and the resulting recommendations are made on each issue.

Questions: How can our AA Group help run AA worldwide?

Answer: Your group can help by electing a GSR, discussing and taking group consciences on the issues your GSR brings to your group for discussion, and sending your GSR to your District's monthly meetings and to your Area Assemblies (which meet 3 or 4 times a year) and to the workshop that meets in March of each year where votes of the Groups (via their GSRs) are taken.

Question: Are there committees that help run AA worldwide?

Answer: Yes, there are several committees that operate at the National level. They include such committees as PI (Public Information), CPC (Cooperation with the Professional Community), Corrections Facilities, Treatment Facilities, etc.

Question: What is the difference between the General Service Office and our Central Offices?

Answer: There are many Central Offices, and each one services the needs of AA groups in their local vicinity. Their services usually include storing and having available for purchase various AA literature items (e.g. books, pamphlets, tapes, videos, forms, magazines, etc.) , making 12th Step Calls, Maintaining lists of times and places of local AA meetings. Our local Central office is located at 133 West Chapman Ave., Suite, Fullerton, CA 92832.

Question: What kind of services does the General Service Office offer?

Answer: They provide many services to AA at both the National and International level. These services include the following:

- Helps new AA Groups to get started
- Stays in contact with each registered AA group via the groups GSR or contact point
- Publishes and stores conference approved AA literature. Some of this literature is available in over 50 languages.
- Provides conference approved literature to AA individuals, Groups, and Central Offices. Maintains AA's Archives
- Hosts the yearly General Service Conference
- Handles all public relations
- Publishes the AA Grapevine & La Vina monthly magazines
- Puts on International Conventions
- Maintains Committees for:
 - Cooperation with the Professional Community,
 - Public Information,
 - Corrections Facilities
 - Treatment Facilities

Question: What are some of the issues that the AA groups (through its GSRs) have previously had to discuss, take group consciences on, and send via their GSRs?

Answer: One of the issues has been whether or not to revise the wording in the Big Book to bring it into more up-to-date language. This issue has been hotly debated many times (in many years) and, so far, the group conscience of AA as a whole has been to leave the language the same as what Bill W. wrote. The stories at the end of the Big Book are updated (some new ones added, some old ones deleted) in each edition of the Big Book.

Another issue was whether or not AA should defend its copyright to the book "Alcoholics Anonymous" in a court of law. Such defense would involve expenditure of AA funds, and hence had to be decided by AA as a whole. After much discussion, the decision was to go ahead and spend the money need to defend this copyright, so that others could not re-issue and perhaps change our book.

Question: What are “The Twelve Concepts” and why did Bill W. come up with them?

Answer: The Twelve Concepts were written by Bill W. in 1962 as a guide to how AA groups could run AA as a whole, even after its founders had passed on. The short form of these concepts are printed below:

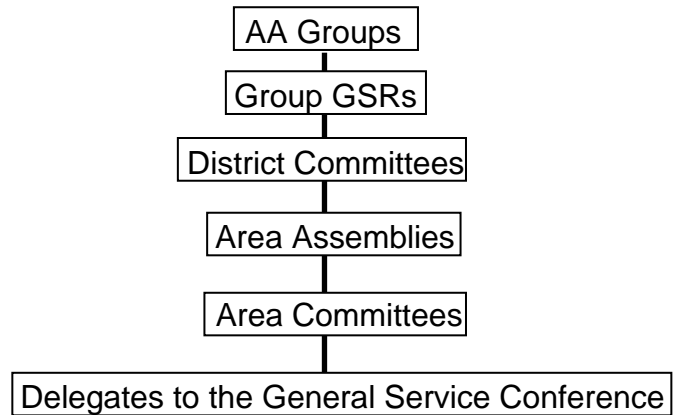
The Twelve Concepts (Short Form)

- I Final responsibility and ultimate authority for A.A. world services should always reside in the collective conscience of our whole Fellowship.
- II The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs.
- III To insure effective leadership, we should endow each element of A.A. - the Conference, the General Service Board and its service corporations, staffs, committees, and executives - with a traditional “Right of Decision”.
- IV At all responsible levels, we ought to maintain a traditional “Right of Participation,” allowing a voting representation in reasonable proportion to the responsibility that each must discharge.
- V Throughout our structure, a traditional “Right of Appeal” ought to prevail so that minority opinions will be heard and personal grievances receive careful consideration
- VI The Conference recognizes that the chief initiative and active responsibility in most world service matters should be exercised by the trustee members of the Conference acting as the General Service Board.
- VII The Charter and Bylaws of the General Service Board are legal instruments empowering the trustees to manage and conduct world service affairs. The conference Charter is not a legal document; it relies upon tradition and the A.A. purse for final effectiveness.
- VIII The trustees are the principal planners and administrators of overall policy and finance. They have custodial oversight of the separately incorporated and constantly active services, exercising this through their ability to elect all the directors of these entities.
- IX Good service leadership at all levels is indispensable for our future functioning and safety. Primary world service leadership, once exercised by the founders, must necessarily be assumed by the trustees.
- X Every service responsibility should be matched by an equal service authority, with the scope of such authority well defined.
- XI The trustees should always have the best possible committees, corporate service directors, executives, staffs, and consultants. Composition, qualifications, induction procedures, and rights and duties will always be matters of serious concern.
- XII The Conference shall observe the spirit of A.A. tradition, taking care that it never becomes the seat of perilous wealth or power; that sufficient operating funds and reserve be its prudent financial principle; that it place none of its members in a position of unqualified authority over others; that it reach all important decisions by discussion, vote, and, whenever possible, by substantial unanimity; that its actions never be personally punitive nor an incitement to public controversy; that it never perform acts of government, and that, like the Society it serves, it will always remain democratic in thought and action.

What is the General Service Structure?

Answer: AA World Services is run by the trustees, and guided by the group conscience of all the AA groups in the US and Canada. The structure and process for collecting this group conscience from AA as a whole is called the “General Service Structure.”

The groups participate in this process by electing a GSR in each group, and having this GSR carry the group conscience (vote) on each issue to that Group’s Delegate. The Delegates from each of the 93 Areas in the US and Canada then meet once a year (at the “General Service Conference”), carrying the votes of their groups (as communicated by their GSRs), to decide on all the issues being considered that year. Each issue is discussed by the delegates, and the opinions and group consciences of their groups are shared. The resulting recommendation on each issue is then communicated to the Trustees, who then have the power to enact these recommendations.



Our Area (9)

Area 9 (Mid-Southern California Area)

Area 9 includes all AA groups in the counties of Orange, Riverside, San Bernardino, and the part of Los Angeles County south of Rosecrans Ave. There are 23 districts in Area 9. Eighteen of them are English speaking, and 5 are Spanish speaking. There are over 2000 AA groups in Area 9.

My Two Sponsors

Website: The General Service Office maintains an extensive website at www.aa.org. The website is maintained in 3 languages: English, Spanish and French. Among many other things, you can read and/or download many of our pieces of AA literature (including the big book of Alcoholics Anonymous!), and you can be linked to a variety of Central Offices and Areas across the U.S. and Canada. You can also order subscriptions to the Grapevine on-line, and can view its literature catalog on-line. You can also find out about the Archives of AA which contains personal collections, manuscripts, publications, photographs and memorabilia related to the origin and the development of the AA fellowship.

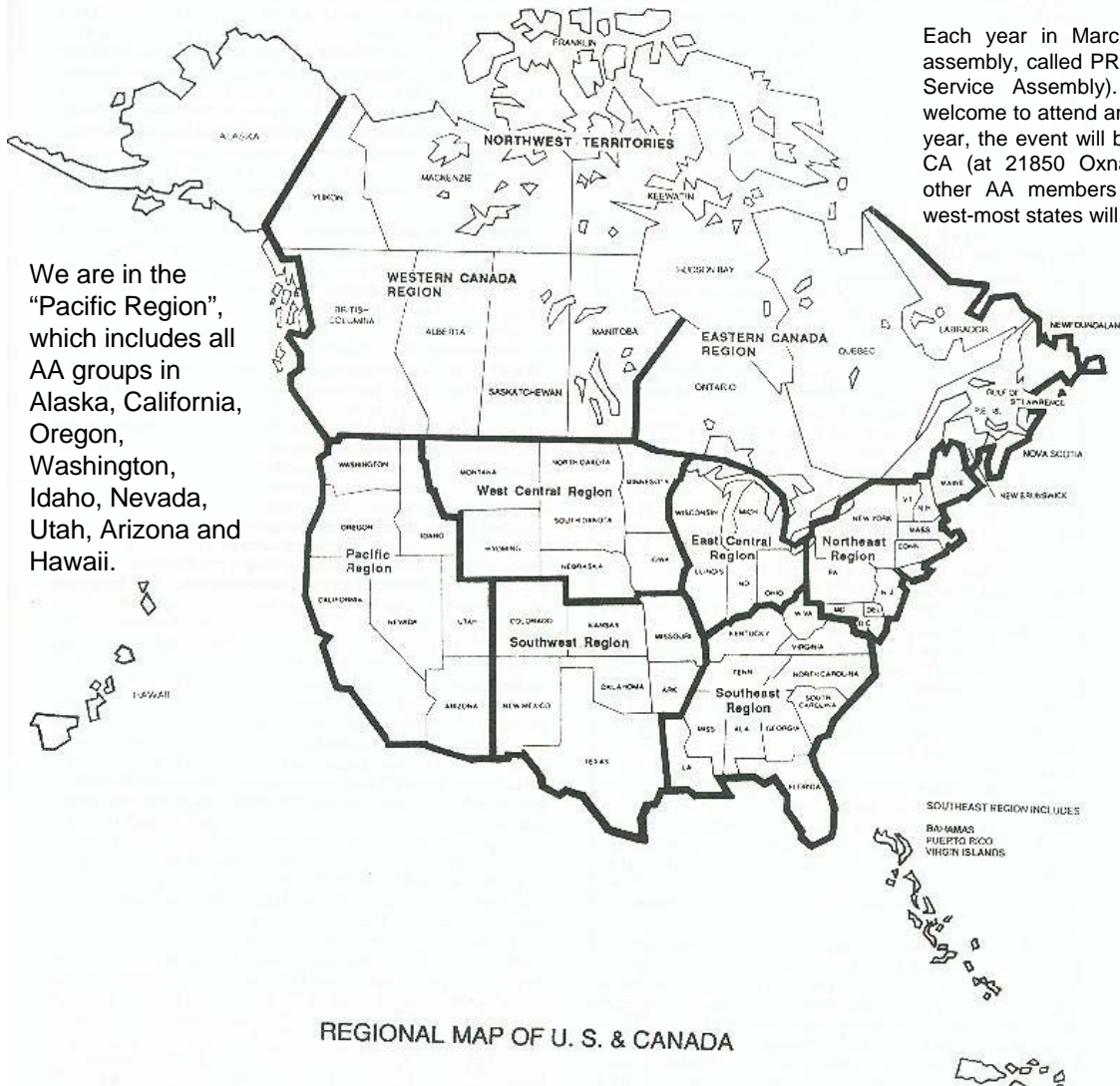
