It is hard to believe the year has almost ended. As of December 11, 2008 we had income =65,807.08 compared to 64,732.77 in December 11, 2007. However, our expenses in 2008 were 69,963.90 and 2007 were 69,482.09 our balance has been reconciled as of 11/30/08.

Because of some ideas we had in our October finance Committee meeting, and the positive attitude of the members of the Finance Committee, I came up with some of my own when I told Joseph he said "I don't think I want to hear this". It was a simple idea. Area 09 does not have birthday envelopes like general service does, so I spent some of my personal money and introduced these to district 1 and Fey Y E. in District 23. Quite simply they have a small decal in the left hand corner to designate it as a birthday envelope. District one gave 50.00 in individual and birthday donations, district 17 gave 50.00 from one individual.

I also checked with the Irvine post office to see how much it would cost to have the mail delivered to my personal address from the post office box in Irvine to Torrance. I was told it was a 10.00 initial fee and 11.95 per week. This way I could save the areas some money and get the contributions done once a week. Also I visited district 1 and district 3 and Cesar asked Mike and me to join him in talking about the Seventh Tradition in Perris and enjoyed helping with the Elections in Area 93.
