District Archivist Workshop

The Archives Workshop held January 15th, was a total success! Although we had to move the date back a week because of bad weather, we had 16 interested members who all wanted to learn more about archives and how to collect and preserve our history.

We covered such topics as "I am a District Archivist, now what?" and "How to do oral histories." During the segment on "How to do a Group History," we showed samples of the material housed in the Archives that will help in compiling Group histories. Sources included old newsletters, meeting directories, old Grapevines along with several others. There was even a brief talk on how to preserve the document that might be collected. Things such as dust jacket covers, acid free folders, and storage boxes were discussed. A lot of questions and answers ended the program with much discussion on many of the topics covered during the day.

The coffee, chili lunch and fellowship couldn't be beat, and despite having to change the date, the Archives Committee deemed the event as a success. The Archives Committee has decided this maybe a worthwhile endeavor and will surely plan another one at a later date. The committee is even considering doing something like it, on a smaller scale, at the monthly Area meetings, as a way to help train and equip District Archivist in their job of preserving their district history.

If your District does not have a District Archivist, we suggest you elect one soon. As we plan more and more events centered on these archivists, we would not want your district left out. If you have any questions about how your district can get more involved in the Archives, please feel free to contact us. Many Areas Link to Central Offices

Many AA General Service Areas in the U.S. have web sites. I find it very interesting to look at these websites to see what our sister-areas are doing. The aa.org website has a list of (and a link to) about 50 of these Area websites. To find them, go to aa.org, click "Services for Members", then click "Contact Local AA" (yellow tab near top of screen), then click "General Service Conference Area Web sites". You can use this list of links to go to one area web site after another. Many of them list meetings right on their websites. Many others link to their local central office websites to help folks find meetings. Our MSCA website will also soon link to consenting local central offices (i.e. those who give us permission to list their addresses, phone numbers, and to link to their websites) in our area. We are in the process of asking the central offices if they would like to be listed so that when non-local AAs come to our Area, and come to the MSCA web site to find a meeting, we can help direct them quickly to our local central offices and their contact points and meeting lists.

Service Material

As many of you know, service material differs from Conference-approved literature in that it has not come about through Conference Advisory Action. It is produced when there is a need for readily available information on a specific subject. Service material reflects A.A. group experience as well as specific and timely information that is subject to change. Service material is available to A.A. members from the General Service Office upon request.

“As you know, one of the more “slippery” places in the journey to sobriety is between the door of the (treatment) facility and the nearest A.A. group or meeting... In order to bridge the gap, A.A. members have volunteered to be temporary contacts and introduce newcomers to Alcoholics Anonymous... It is suggested that the temporary contact take the newcomer to a variety of A.A. meetings; introduce him or her to other A.A.'s; insure that he or she has the phone numbers of several A.A. members, and share the experience of sponsorship and a home group.”

Just go to aa.org, click on “Services for Members”, then click on “Contact Local AA” (a yellow tab), then, at the bottom of that page, click on “Central office, intergroup or answering service of U.S. and Canada” or click on “General Service offices, Central Offices, Intergroups and Answering Services Overseas”.

Also, please note that the February Delegate Sharing Session will begin discussion on various agenda items (for the upcoming General Service Conference) and what they mean to us.

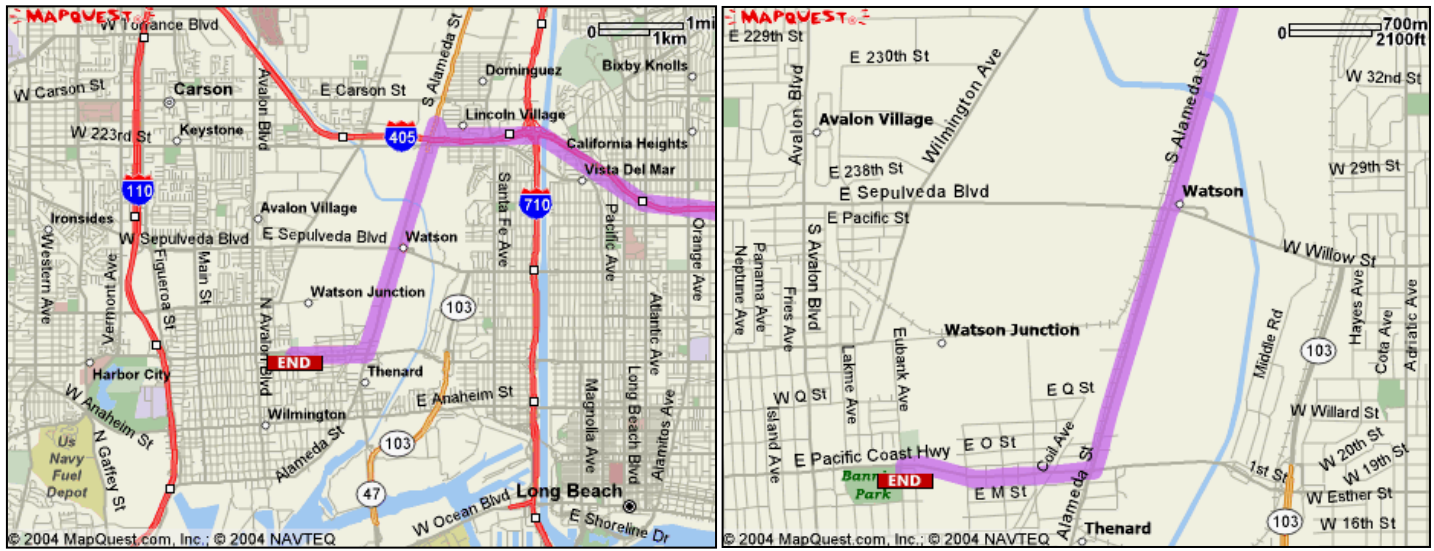

For our group purpose there is but one ultimate authority – a loving God as He may express Himself in our group conscience.

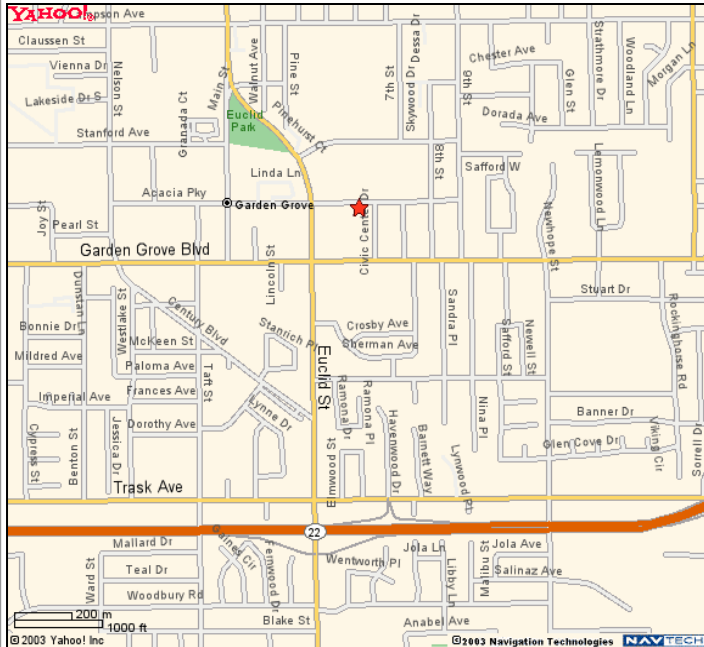
